#### Veteran and Spouse Transitional Assistance Grant Program

Provides grants to eligible organizations that offer transition services to former members of the U.S. Armed Forces and their spouses. These services include employment-based resources, resume assistance, interview training, job recruitment, and other tools to facilitate a successful transition.







# **Eligible Participants**

Participants served by this program include former members of the U.S. Armed Forces who are separated, retired, or discharged and their spouses.









# **Key Laws and Regulations**

### Public Law 116-315, Section 4304

- Grants for provision of transition assistance to members of the Armed Forces after separation, retirement, or discharge published on May 13, 2024.
- Public Law 116-315
- Veteran and Spouse Transitional Assistance Grant Program (va.gov)

### 38 C.F.R. Part 80

- Became effective June 12, 2024.
- Sections 80.1 through 80.17 establish rules and guidelines for the new grant program.

### **Eligible Award Recipient Organizations**

# **Eligible recipient** means one of the following:

- State government;
- County government;
- Local government;
- Institution of Higher Education;
- Indian/Native American Tribal government (federally recognized);
- Nonprofit organization; or
- Faith-based organization.

# **Evaluation Criteria**

A comprehensive assessment framework that identifies key strengths and areas for improvement, ensuring well-informed recommendations across the following categories:

- Statement of Need: Alignment of the project with identified needs and strategic objectives.
- Project Design: Effectiveness and innovation in the project's structure and approach.
- Organizational, Administrative, and Fiscal Capacity: Proven capability to manage resources and deliver results.
- Past Performance and Programmatic Capability: Track record of successful project execution and impact.
- Budget and Budget Narrative: Financial soundness and justification of resource allocation.







# **Award Selection Process Framework**

VA will only score **complete** applications received from eligible applicants by the deadline established in the Notice of Funding Opportunity (NOFO).

Additional factors for selecting applications:

- -(a) Applicant's performance on prior award.
- (b) Applicant's fiscal integrity.
- (c) Priority preference: Priority preference will be given to organizations that either provide multiple forms of services or are located in a State with high rates of unemployment among Veterans and other economic factors.
- (d) Risk assessment evaluation.
